## **OPINION SURVEY REPORT**

### PRAIA, SÃO VICENTE AND SANTA CATARINA DE SANTIAGO

#### **METHODOLOGY**

Datasheet

**The demand:** Evaluation of public opinion in relation to the political environment as a result of the Justice cases - Alex Saab and Amadeu Oliveira, as well as a brief overview of the presidential elections.

### **Technical proposal**

Target Audience: Individuals over 18 years old and with electoral capacity in the constituencies of Praia, S. Vicente and Santa Catarina de Santiago.

**Sample:** Was stratified by age, sex and area of residence. The proportional sampling method was used and the confidence margin is 98%.

Samples: distributed by Praia – 578 S - S. Vicente – 398; and Santa Catarina – 331 people surveyed.

Margin of error: 2.5%

Reliability coefficient: 97.5%

#### **Data collection**

Data collection in the field took place between the 10th and 14th of September 2021. Eight surveyors participated in it, covering all areas of the aforementioned municipalities.

In this work, a total of 1,194 people were surveyed, geographically distributed by gender and age group as follows:

Distribution by gender – Overall, 542 men and 652 women were surveyed.

Distribution by age groups were surveyed globally -18/34 - 582; 35/54 - 441 - 55/80 - 171 individuals.

The technique of direct and personal interview was used, through a questionnaire structured by the Consultant and approved by the client.

The questionnaire was written in Portuguese. Whenever people were found who did not understand Portuguese, or who did not understand a word, the questions or words in question were translated into Creole and explained by the interviewers.

#### **EXECUTIVE SUMMARY**

After analysing the data and information obtained during the interviews, we have the following observations to report:

Respondents stated that they voted mainly for the MpD and PAICV and according to the results framework that actually took place. The MpD was identified as the political force that received the highest number of votes, considering the totality of the three most populous cities in the country.

The evaluation of the Government's performance is globally positive, with greater emphasis on the classification of Reasonable/Fair.

#### **Evaluation of the Constitutional Court decision**

Respondents negatively assess the Constitutional Court's decision not to recognise the unconstitutionality of Alex Saab's extradition decision. Considering the three main cities, the negative critical ratings of Totally Illegal ranged from 13.6% in Praia to 15% in Santa Catarina.

Most respondents consider that the Constitutional Court's decision was incorrect, with greater expression in Santa Catarina 56.8%, Praia 35.2% and São Vicente 32.2%.

#### **Process delay**

Most of the interviewees attributed the delay in court decisions to pressure exerted on the Judicial Decision-makers in order to make the extradition of Alex Saab feasible. This understanding is shared almost equally in Praia, S. Vicente and Santa Catarina. In a different sense, about 20% of people believe that this was due to a lack of understanding among the judges. A small part of the interviewees was unwilling or unable to respond.

#### **Diplomatic status**

An expressive majority of those interviewed believe that the State of Cape Verde - Government and Justice - violated Alex Saab's diplomatic status. In this sense, 60.2 % responded in Praia, S. Vicente, 40.2 and Santa Catarina, 64.4 % A small part, on average in the order of 17.2% did not know how to answer and 21.2% thinks that there was not any violation of Alex Saab's diplomat status.

#### **Evaluation of the intervention of the President of the Republic**

A large number of people questioned consider that the President of the Republic did not have the strength or courage to enforce the diplomatic status of Alex Saab, in other words, the international commitments assumed by the State of Cape Verde. In this sense, Praia, (55.8%) S. Vicente (33.2%) and Santa Catarina were considered. 62%.

#### Alex Saab Prison Maintenance in prison

The maintenance of Alex Saab's prison is also condemned by a clear majority of respondents to the inquiries. Praia (57.4%) S. Vicente (39.6%) and Santa Catarina (60.1%) A much smaller percentage think that the actions of Cape Verdean authorities are normal and legal.

### USD 400 million in counterparts offered to Cape Verde

Regarding the 400 million dollars in compensation offered to Cape Verde by the United States of America, a large number of people believe that this will have somehow been a bargaining chip for the decision to detain and extradite Alex Saab. Averaging the three largest population centres, more than 65% of people agree with this conclusion.

#### Future vision in relation to the image of Jorge Carlos Fonseca

Regarding the future vision of respondents in relation to the image of Jorge Carlos Fonseca, almost half think he will be remembered for sponsoring the violation of the Constitution of the Republic and for not having defended the fulfilment of Cape Verde's international commitments. In this sense, Praia (44.2%) expressed more opinion in S. Vicente (43.8%) Santa Catarina (54.15). On average, 35% expressed their opinion that he will be remembered as a politician who will not leave marks beyond the period of his two presidential terms.

#### Transfer to Praia of Alex Saab

The overwhelming majority of people, on average around 80%, think that the Court of Appeal's delay in determining the transfer to Alex Saab to Praia for better access to specialised medical care constitutes an act of violation of his most basic rights which is the care and provision of health care. Only a small percentage of respondents think that this delay was due to procedural and bureaucratic issues. A residual number of people were unable or unwilling to respond.

#### Responsibility for violations of law and to Alex Saab's rights

Regarding responsibility for violations of the law and to the rights of Alex Saab, most respondents point to the Justice system Praia (34.4%), S. Vicente (10.7%) and Santa Catarina (29.75) respectively. In second place comes the Government, with a weighted average of 35% and the United States of America, with about 15% of the nominations of the respondents.

#### Consequences of the management of the Alex Saab file by the State of Cape Verde

Regarding the consequences of the management of the Alex Saab file by the State of Cape Verde, most respondents believe that this will negatively affect the country's image and its diplomatic and cooperation relations. In this sense, Praia (62.8%), S. Vicente (53.7%) and Santa Catarina (81.2%),

#### Impact on the flow of tourists to Cape Verde

Regarding the negative impact on the flow of tourists to Cape Verde, opinions are divided: on average, 37% believe that it harms and 39%% believe that it will not have a major impact.

### Impact of legal decisions on the image of the Justice system

Considering the impact of the legal and court decisions relating to the Alex Saab case, people's view is that it is "doubtful and inspires little trust." This is what 45% of the people surveyed believe, while 12% think it is "credible and trustworthy". A small part of the respondents was unable or unwilling to answer.
















